1. Preamble: the present state of the fight against corruption in Tu isia

For the first time in its history, Tunisia adopted in late 2016 a national stategy for good governance and anti-corruption and an associated action plan covering 2017 and 2018. The second national action plan was also adopted in the framework of the open government partner hip. A baseline study about governance in the framework of Sustainable Development Goal n°16. In tails regard, it is important to highlight the participatory approach that characterized these tracks, which often facilitated the implementation of their components.

To strengthen accountability and participation, a project on supporting youth participation in public life is being pursued, with the support of OECD, in parallel with the adopt in of a national strategy for youth.

In a related context, the electoral process witnessed a real revolution by establishing horizontal and vertical alignment in the lists of candidates for the electoral eligibility at the local level in addition to supporting the representation of youth and people with special needs.

During the same period, the results of the first cycle of the UNCAC review mechanism led to the development of the legal and institutional framework, especially through:

- The approval of the Arab Anti-Corruption Convention (Organic Lat No. 2016-73 of November 15, 2016)
- The setting up of the judicial economic and financial center (C ganic Law n ° 2016-77 of December 6, 2016)
- Whistleblowing and whistleblowers protection law (Organic law n 2017-10 of March 7, 2017)
- Governance and Anti-Corruption Commission (Organic law n° 201 -59 of August 24, 2017)
- The declaration of assets and interests and the fight against illicit enrichment and conflict of interests (Law n° 2018-46 of August 1, 2018)
- Government Decree No. 2016-1158 of August 12, 2018, establi hing governance cells and fixing their attributions.
- Government Decree No. 2016-1098 of August 15, 2016, establishing the organization and operating procedures of the Tunisian Financial Analysis Commission (FIU).
